Eligibility Requirements:

- ✓ All students who wish to borrow federal student loan funds must have a completed 2019-2020 Free Application for Federal Student Aid (FAFSA) on file with Temple University.
- ✓ Non-matriculated students who are required to complete courses as part of *admission/entry* into a degree granting program at Temple University have one year (12 months) of eligibility to borrow a Federal Direct Student Loan and/or Parent Loan for Undergraduate Students (PLUS) based on continual enrollment.
- ✓ A Non-Matriculated Graduate Student cannot borrow a GradPLUS loan.
- ✓ New loan borrowers must complete an Entrance Interview by going online to www.studentloans.gov.
- ✓ Students receiving Federal Direct Student Loan Funds as a non-matriculated student, must not have received Federal Direct Loan Funds as a non-matriculated student in any prior academic year.
 - **Students are only eligible to receive Federal Direct Loans when their status is a non-matriculated student *once*.**
- ✓ Please contact Student Financial Services (SFS) for information on your maximum borrowing eligibility during your enrollment.
